The **8u QuickStart League** is for children ages 6-8 who have participated in a series of lessons and are familiar with keeping score. The focus of the division is to introduce match play in a non-competitive environment. Scores will be recorded, however all players are winners.

Who? Players 8 and under recommended by their tennis instructor.

When? Friday afternoons, approximately 6-8 weeks, starting on or about March 11th, match time approx 1 hour.

Where? Teams are facility based and matches will be played on the 36 ft QuickStart court, where courts are available such as, Bishop Park, Jennings Mill CC, and Herman C Michael.

Why?

- Put your child's skills to the test. Give them the opportunity to play against another player!
- Give them the opportunity to learn how to keep score in a non-competitive environment!
- Prepare them for competition at the next level of 10 and under!
- Expose them to tennis as a team!
- Be a part of their tennis learning experience & you too will learn to score!
- Keep them ACTIVE!

Match format will be 4 individual singles matches, possible doubles play. Parent involvement is required.

USTA Membership is required. Junior membership is \$19.00 per year.

Fall League fee is \$40.00 paid online through TennisLink. (League fee includes any court fees, equipment, balls, uniform shirt, TennisLink fees, & awards.)

Registration is a two-part process:

Step 1: Complete attached form and return to your pro. Pros will organize teams and captains.

Step 2: Online registration. Your pro/captain will contact you and provide you with online registration instructions. Fees will be paid online via credit card. NO Refunds after Tennislink registration.
